ORDER.

The Texas Ethics Commission (the "Commission") met on May 28, 2014 to consider Respondents' Objections and Motion to Quash Texas Ethics Commission Subpoents to Michael Q. Sullivan and Empower Texans, Inc. (the "Motion to Quash"), as part of a pre-hearing conference conducted in connection with the formal hearings in the above-captioned matters.

The Commission has considered the Motion to Quash, the written response by Commission staff, and the arguments of counsel for Respondents and Commission staff at the May 28, 2014 prehearing conference. Based on the foregoing and the applicable law and rules, the Commission

ORDERS as follows with respect to the subpocnas issued on April 3, 2014 in connection with the above-captioned matters:

- (1) The definition of "Communication" in the subpoenas is restricted to "letters, emails, and faxes."
- (2) The definition of "Document" in the subpoenas is restricted to "every responsive writing or record of whatever type and description in the possession, custody, or control of Empower Texans, Inc."
- (3) The definition of "Empower Texans" is restricted to "Empower Texans, Inc. and any of its officers, directors, and employees."

(20) Respondents shall comply with production of documents responsive to the remaining categories set forth in the Documents Requested (Categories 1, 3, 5, 7, 9, 10, 11, 13, and 19, as modified above, and 15 and 16) to Commission staff, or a statement provided to Commission staff that any and all responsive documents have previously been produced to Commission staff, by no later than June 13, 2014.
